SECOND:

The purposes for which this corporation is formed are as follows:

- (a) The specific and primary purpose is to act as a management body for a condominium project located on that certain real property in the County of Los Angeles, State of California, generally known as: THE VILLAGE GREEN OWNERS ASSOCIATION and more particularly described in a declaration of covenants, conditions and restrictions recorded or to be recorded with respect to said Project (hereinafter referred to as the "Declaration"), together with any other condominium projects which may become subject to said Declaration pursuant to the provisions thereof.
