Board of Directors December Meeting News

After two homeowner comments, the board considered seven business items; 11 design review recommendations; correspondence; and reports.

Actions included:

2017 Insurance Package... approved a \$152,747 package from Farmers Insurance including property and liability, director and officer liability, and umbrella liability coverage.

Common Area Use... discussed the use of common area green spaces for commercial recreation and denied a request for use of the Green for a paid weekly children's soccer class.

2017 Inspectors of Election... appointed Cynthia Cyrus, Rob Creighton and Heide Oglesby as Inspectors of Election, with Mickey Fielding as alternate.

Meet the Candidates... asked Court Council to organize Meet the Candidates events on January 17 at 6:30 pm and January 21 at 10:00 am at the Clubhouse. Candidates will speak and take questions.

Suspended Voting Rights Hearing... appointed two directors to conduct a hearing on January 26 at 7:00 pm for ineligible owners wishing to appeal. □

Village Green: '...an inspired piece of urban design ...'

As Village Green enters its 76th year, Highlights salutes the volunteers who produced the extraordinarily successful "75th Anniversary Celebration and Holiday Party" last month.

Our community would not be the same without its architectural design, and the party began with a slide show and talk from resident and art historian Gailyn Saroyan illuminating this connection. Here are a few excerpts from her talk.

Village Green's design was grounded in the Garden City architectural movement, which built moderately-priced urban housing that fostered community and connection with the outdoors. It was designed under the leadership of Reginald Johnson, the most distinguished architect ever to design a Garden City in the United States. Early brochures touted the property as a new kind of "Village in the City" that would "Tame the Car," where residents would feel like they were "Living at the Country Club."

Our consulting architect, Clarence S. Stein, was the most distinguished urban planner of the 20th century and an American champion of Garden City principles adapted for the motor age. Stein said that Village Green was the most complete and most characteristic expression of his ideas ever built.

What makes Village Green so architecturally significant?

In 1998, Pulitzer-prize winning architectural critic Allan Temko characterized its graceful unity of design like this: "Village Green is one of the great monuments of environmental humanism in the United States...it's an inspired piece of urban design...a masterpiece in its grand design and the refinement of its nuances."

In 1970, the American Institute of Architects (AIA) launched its prestigious 25 Year Award, to be given to just one piece of architecture in the nation per year. The first recipient was New York's Rockefeller Center. In 1973, the winner was Frank Lloyd Wright's Taliesin West. In 1972, the award went to Baldwin Hills Village, i.e., Village Green! And later, the AIA also chose Village Green as one of the top 100 architectural achievements in American history.

Party Chef Reveals Secrets, Thanks Community

From the beginning, I knew I wanted to cook food that was specific to the period. Unfortunately, the 40s were a terrible era for cuisine. Lots of grey food, rationing, and government propaganda to introduce organ meats into the mainstream.

How could I make the food look vintage but update the flavor profile? For example: liver and bacon were a classic food combo in the 40s, and prunes were practically the poster fruit for the period. I chose to incorporate bacon and liver into a mousse, then used prunes for a chutney that would go on top. Visually, you end up with a vat of grey paste topped with a spoonful of brown mush all on some colorless toast.



The trick would be to make the bland-looking 40s food pop with big flavors. *Behind the scenes:* the liver was marinated in brandy, bay leaves and raw garlic to minimize their minerality, then braised in a cream infused with sage and thyme, and then blended with pancetta, sweet vermouth, and balsamic vinegar for depth and acidity. The chutney itself was stewed with cinnamon, nutmeg, and sherry to evoke certain holiday sense memories, but also so it would pair well with a big glass of homemade egg nog if desired.

Help Needed, Help Given

Once the menu had been decided, food prep for the event took me just over two months. Neighbors from all corners of the Green made room in their kitchens to accommodate the components we could freeze ahead of time. In the final minutes before showtime, the cultural affairs committee sent out an SOS text - and it was only SECONDS before eager neighbors were ready and willing to assist.



And really, that's the magic of this place - this community has always got your back. From me and Lindsey and our twins Hero and Max, we'd like to say a deep and sincere thank you to everyone who works so hard to maintain the magic of the Village Green. For your energy, your enthusiasm, your vision, and your love - thank you for making your neighbors a priority in your lives.

Manager's Report

WASH Laundry Machines:

Some residents have complained about difficulty adding additional time to dryers after the cycle has begun. WASH informed management that as long as 7 minutes remain in the cycle, a user can add 10 extra minutes for 25 cents. After that, extra minutes will be charged for a full cycle.



Concrete Repairs:

Concrete sidewalk and patio repairs are under way, with 48 scheduled for completion by the end of December.

Irrigation Well:

Following November's installation of a flow meter and transducer (data logger), the ongoing periodic testing and monitoring program is expected to commence in late December.

Garage Restoration and Residential Painting:

The restoration process in garage courts 9, 10, and 11 is on-track to be completed in December. Management continues to seek appropriate bids for residential painting and carpentry repairs.

Garage Inspections:

Management continues to re-inspect and "clear" garages.

Annual Roof Cleaning:

The project concluded on December 2.

Landscaping RFP Process:

Management continues to clarify inconsistencies in bids received.

Dead Tree Removal:

This process continues to take place concurrent with the arborist's ongoing inspections of the forest.

2017 Reserve Study:

The study was completed by Association Reserves, Inc. in November and included in the Annual Disclosure packet mailed to members in late 2016. \square

The board has approved \$500.00 for the purchase of Dusk-to-Dawn CFL light bulbs for porch and patio lighting. **They are available free to residents while supplies last.** These very efficient bulbs have photo sensors that automatically turn lights on in the evening and off in the morning. This is part of a pilot program to encourage residents to leave porch and patio lights on through the night.
