April Board Meeting Lively and Varied By Lucy Fried

Change in Garbage (Green Bins) Service

Directors approved a change that will save the Association almost \$18,000 a year. The green garbage bins *(for trash that cannot be recycled)* will now hold four instead of three cubic yards and be serviced on Monday and Friday only instead of three times a week. No other changes are planned. An eightweek feasibility study conducted by the facilities engineer showed that the amount of garbage currently deposited in the green trash bins reaches or exceeds capacity in two courts.

Guest Speaker and Residents' Comments

To start the evening, Mr. Kimani Black, from Councilman Herb Wesson's office, reported that the permit-only night time traffic district on Coliseum between LaBrea and Hauser is in place. Now Hauser and Sycamore residents are waiting eagerly for relief from the large trailers and trucks that park overnight near them.

Six residents also spoke. One suggested management provide a list of contractors who will change electric to gas appliances. Four complained of excessive noise from unaware upstairs neighbors and inadequate noise insulation; one had a question about Greencrew; and one complained that maintenance and vendor carts ride roughshod on the grass and drag mud around.

APRIL MANAGER'S REPORT

DWP News: April brought two pieces of good news from DWP: (1) recent maintenance work in Courts 1 and 2 underground electrical vaults is expected to shorten the repair time for events like the February 13th power outage; and (2) they have replaced a faulty capacitor at an off-site generator station that was responsible for the multiple shutdowns of our well pump.

Management tasks this month included preparations for major maintenance projects approved for 2018:

Replacement of Interior Water Lines: Buildings 69, 70, 71, 72 and 73. Owners and renters have received notices of information meetings on Thursday, May 3rd and Saturday, May 5th and are encouraged to attend to get a first-hand understanding of the scope of this work.

Pet Policy Meeting

Acting on a resolution from the appointed Pet Task Force, the Board requested they organize a meeting for all residents on Village Green's pet policy and enforcement as soon as feasible. Pets were not allowed in Village Green until 2009, when the current lengthy policy was crafted after many, often contentious, meetings and has not been reviewed since then. Directors encouraged *all residents to read the policy in the Handbook before the meeting*.

Reports

The Board approved the final 2017 Audit Report from independent auditor Creighton Tevlin, CPA.... Directors also noted the April Arborist Report from arborist Cy Carlberg, which recommends seven trees for removal and replacement. Six are Sycamores that have been unsuccessfully battling the Polyphagous Shot Hole Borer for several years. She recommended treating some of the healthier Sycamores with tree injections to help combat the borer presence. □

Village Green Delinquencies and Misconceptions

We've all heard it. Delinquencies are too high and out of control; my neighbor tells me a person in our court hasn't paid their assessment in years, with no intervention; why doesn't the Board do something? But, is that fake news?

Here Are the Facts

We have two classes of delinquencies: delinquent assessments (regular and special), which lead to foreclosure; and delinquencies from other causes such as unpaid work orders, garage and parking fines, collection costs, and late charges. *The focus of this article is delinquent assessments.*

The Association aggressively follows a process defined by state law and our practices. An assessment becomes delinquent 15 days after its due date. At 45 days after due date, Ross Morgan sends the owner a pre-lien letter notifying the owner that their payment is delinquent.

If payment is not received at about 30 days after the prelien letter has been sent, and the total of the assessments delinquency has reached \$1,800, a lien resolution is sent by Ross Morgan to the Board for approval at their next meeting.

If the board approves the lien, and payment is still not received at about day 75, a lien may be recorded. If payment is still not received at day 105, a Notice of Default (NOD) may be recorded. If payment is still not received at about day 195, a Notice of Sale (NOS) may be recorded. About day 226 is the earliest date for a trustee's foreclosure sale.

Professional Assistance

The Board takes assessment delinquencies very seriously. If the delinquency is not resolved at this point, we then employ our attorneys to work with the owner to establish a payment (installment) plan for paying off their delinquent amounts over time; it is prudent for the Association to attempt to retain the owner. *However, if the owner does not follow through, we may ask the attorneys to carry the process through to foreclosure.*

Our Current Situation

Twelve liens were recorded in 2017 and seven so far in 2018. These liens have resulted in at least three full payments. As of the end of March, there were 12 units with recorded liens, eight units pending liens, and 13 units under review by our attorneys. No delinquent owner can avoid intervention by the Board.

What about those "ever-increasing" assessment delinquencies? The facts are that delinquencies due to unpaid regular assessments have NOT been increasing but rather have remained about the same over the last seven years. The same is true for special assessment delinquencies. The chart below shows that the high numbers for regular assessment delinquencies oscillate between \$158,877 and \$173,571 with no particular pattern.

Non-Assessment Delinquencies:

As of March 31, 2018, these now total \$325,710 or 58.5% of our total delinquencies. I will discuss these delinquencies in an upcoming issue of Highlights. \Box

Spirits Soar at Tree Committee Bird Walk

Saturday morning, April 14, was the perfect time to look for birds and their nests at the Green. Our guides, veteran Audubon birders Dick Barth and Don Sterba, told Highlights they saw 28 different bird species during the two-hour walk! While it's doubtful the rest of us came anywhere close to that number, we were happy with what we did see.

The first sighting was a large Band-tailed Pigeon – California's only native pigeon – perched near the top of a tall Sycamore just outside the Clubhouse. A little further on, we oohed and aahed as two Western Bluebirds, a colorful male and duller female, darted back and forth through the sunlit trees. Then, in a Eucalyptus tree near the southeast edge of the Main Green, walkers with good binoculars spied a Hawk's tail sticking out from a nest they recognized from last year. Could this nest be in use again?

Birds and Beetles

Jeff Clark pointed out that Sapsuckers (woodpecker relatives) create organized rows of horizontal holes in their search for sap and the bugs that eat it. "When we see such a hole design," he said, "it's important not to confuse them with holes made by beetles such as the Polyphagous Shot Hole Borer."

Other birds sighted included Cedar Waxwings, Warblers, Dark-eyed Juncos, a Summer Tanager, Hooded Orioles, Finches, Doves, Black Phoebes, Hummingbirds, Pacific-slope Flycatchers, Oak Titmouse, Bushtit, House Wren, American Robin, and Northern Mockingbird.

Everyone had their favorites. "For me," said Teresa Thompson, "the highlight of the walk was seeing a Downy Woodpecker pair making a hole for a nest."
