MANAGER'S REPORT

At this month's meeting the Board of Directors approved the appointment of Lucy Fried as a director. Congratulations Lucy!

The Board approved that owners may install the CRL Guarda Slim Line model security screen door without having to go through the design review process. Instead, simply submit a modification request directly to the Office.

The Board also approved one lien, the installation of two sliding glass doors, three security doors, a gas range, one tank-less water heater, a washer and dryer, changes to one patio, installation of cable TV wire in wall, new LED light fixtures and wrought iron guardrail stair replacement.

Please note that annual garage inspections started the week of June 29. We will be contacting you prior to the inspection to gain access to your garage.

Management reported that the 2013 exterior painting to residential buildings 10, 12, 29, 34 and 63 is complete. The schedule for the remaining buildings to be painted this year are 68 (in progress), 72 (July), 75 & 78 (September), and 82 (October).

Painting of the exterior garages and trash areas at Courts 7 and 8 will be done this year. Prior to painting, fumigation of all garages in these courts is scheduled for August 6-8. Garage restoration in Courts 7 and 8 is scheduled to begin following garage inspections.

New signage for trash areas has been approved and the order will be placed this week.

Sewer line replacement in Courts 13 and 16 is complete.

Carob tree replacement planting on Rodeo Road is scheduled to begin this week.

Full minutes of all Board meetings are available for residents to view at the Office during office hours.

Residents may participate in the public comment period at the beginning of each Board Meeting.

Board Meetings occur the fourth Tuesday of each month at 7:00 p.m. in the Clubhouse.
