## MANAGER'S REPORT

- Carob tree replacement on Rodeo Road removal has commenced and is scheduled for completion by end of March.
- At its monthly meeting, the Board of Directors approved a contract with Tom Ruzika Lighting to prepare a VGOA exterior lighting report.
- Painting the exterior of ten residential buildings is scheduled to begin March 26.
- Annual roof cleaning has been completed.
- The board is taking action to upgrade signage in the trash areas.
- The sewer line replacement of Courts 13 & 16 are scheduled in April and May.
- New custom-made tile has been ordered for use with the interior re-pipe projects. Owners will be
  offered the opportunity to order this tile directly from the vendor. We will send a letter explaining
  the process.
- Tree trimming of approximately 99 trees in Courts 1, 2, 3, 4, 7, 8, 9, 10, 12, 14, 15, and 16 has been approved. Trimming schedules will be posted soon.
- The Association has opened two new bank accounts to ensure the Association's funds would be covered by FDIC insurance.
- A battery recycling box has been installed on the leasing box post located by the Office door. Please dispose of your used batteries in this box.
- The Board is asking for volunteers to serve on a committee to investigate and report on the need to continue supporting Village Green seniors, possibly in the form of a Seniors Support Committee.
- This is a good time of year to check your windows and door(s) to make sure they are operating properly and can properly locked.

Routinely check your hot water heater, especially if it is old.
