MANAGER'S REPORT

At its monthy meeting, the VGOA Board of Directors:

- Made note that Director Robert Creighton resigned his position on the board.
- Elected John Keho as president and Joseph Khoury as vice president.
- Reviewed the VGOA financial reports from last month.
- Discussed the Village Green Budget Committee.
- Approve the replacement of \$81,249 of Special Assessment funds by transferring \$81,249 from the Association's Reserve checking account to the Association's Special Assessment checking account, thereby repaying that account for "borrowed" funds.
- Reviewed committee reports and documents submitted by Court Council, Cultural Landscape Report Ad Hoc Committee, Design Review Committee, Grant Committee, Landscape Committee, and Safety Committee
- Tabled a resolution to replace locks on all laundry & trash areas.
- Approved removal of tree(s) at Units 5472 and 5474
- Tabled a request for an installation of a tank-less hot water heater which required a roof penetration.
- Approved the issuance of one lien.
- Tabled a resolution to approve an audit contract for 2013.
- Voted not to install a meter to measure well water usage.
- Approved a lease agreement for a new copy machine.
- Tabled a resolution to repair a serpentine wall.
- Reviewed an information package for potential buyers of units.
- Approved the 2013 Yard Sale Budget.
- Reviewed six letters from residents.

Manager reported that:

- Proposals for a general consulting contractor and responses to a request for qualifications for the building stabilization project have been sent to the Building Stabilization Committee.
- Time Warner quarterly income was \$9,662.03, over \$5,600 more than expected.
- Drawings indicating existing lighting on the property and recommendations for additional lighting had been received from lighting designer Tom Ruzika.
- The painting of exterior of residential Buildings 82, 10, 68, 29, 34, 12, 63, 72, 75, and 78 has commenced. Buildings 10 and 12 are complete and Building 29 is underway.
- The painting of driveways, notices and stripes in Courts 1, 2, 3, 7, 8, 10, 14, 17, and Rodeo Road are scheduled to commence this week.
- Residential and garage roof repair is being scheduled and should commence soon.
- Sewer Line Replacement at Courts 13 & 16 has commenced and is on schedule.
- New signage for the trash areas is pending input from committees.
- Tree TrimmingPhase 3, which includes 99 trees in Courts 1, 2,3 4, 7, 8, 9, 10, 12, 14, 15, 16, is substantially completed.

Residents may participate in the public comment period at the beginning of each Board Meeting.

Please remember the VGOA Pet Policies including:

- One pet per unit, under 30 lb., with the exception of aquatic animals within an aquarium (max 50 gallons) whose number is not restricted.
- All pets must be registered with the Office and dogs must also be liscenced with the City of Los Angeles.
- A pet shall never be left alone in any patio or on any balcony.
- When a dog or cat is being escorted into our out of an individual unit, it must wear the Association's pet tag and be controlled on a leash not exceeding six feet in length.
