### November 27, 2012 BOARD MEETING NOTES

This month the Board of Directors voted to:

- Approve the 2013 Operating Budget.
- Propose approving existing security doors at Village Green. The board will vote again on a final Design Review Committee proposal that will set forth a standard guideline for future security doors.
- Allow the Cultural Landscape Report Committee to accept a contract proposal from Tina Bishop of Mundus Bishop in order to complete the Cultural Landscape Report. The final contract will be voted on again by the Board of Directors.
- Accept architectural firm Houston Tyner as the contracted architect for the Building Stabilization project. The association will begin contract negotiations with Houston Tyner.
- Record eight liens.
- Propose changes to language in VGOA Handbook (thirty-day notice will be given to residents in order to allow for public comment prior to final vote on changes):
  - Non-substantive changes to language regarding the definition of a 'guest' in section 2.11.
  - o Rework some language in Article 18 related to penalties and violations
  - o Add a smoking ban for common areas and units in section 14.7
  - o Add a plant to the list of prohibited plants
  - Create an automatic disapproval for design applications not approved after 60 days from submittal
  - o Allow bicycles to be ridden at VGOA at night with safety lights
  - Remove the restriction for organized sports activities

Full minutes of all Board meetings are available for residents to view at the Office during office hours. Residents may participate in the public comment period at the beginning of each Board Meeting. Board Meetings occur the fourth Tuesday of each month at 7:00 p.m. in the Clubhouse.
