Notes from the Board meeting on September 22, 2009

Delinquencies

The Board approved one lien resolution for a current delinquency of approximately \$2,500.

Enforcement

The Board discussed enforcement processes within the VG office, complaint forms, and pet registration issues. The Board approved a pet policy reminder letter. The Board discussed parking enforcement trends and noted a reduction in the number of tickets being written.

Approved Expenditures

- The Board authorized expenditures of \$180 to publicize a Neighborhood Watch event.
- The Board authorized an additional expenditure of up to \$300 for an additional light in Court 16.
- The Board approved expenditure of \$10,475 to Ramco Electrical Co. for additional exterior lighting. The budget line has not been determined.
- The Board approved expenditure of \$1,800 for additional chimney caps.
- The Board authorized expenditure of \$143,663 to Mr. Sewer and Angel City Builders for rehabilitating sewers in Courts 8 and 9 and repairing patio concrete. Sewer work to come from budget line 32185.
- The Board authorized expenditure of up to \$60 for expenses for the bird walk on October 4.
- The Board authorized expenditure of \$77,405 to Architectural Resources Group for a Historic Structures Report needed for the Mills Act application. This to come from budget line 61230 or 63055.

Actions with No Fiscal Impact

- The Board will meet with Gafcon on September 16.
- The Board approved another "Movies on the Green" event.
- The Board approved use of new "Request for Modification" forms.
- The Board discussed the work plan for re-piping in Court 5.
- The Board approved forms for owners to purchase additional bathroom tiles
- The Board accepted minor revisions to the VG Handbook for pet rules.
- The Board did not pass a resolution on enforcement procedures for pet rules.
- The Board approved a pet registration form.
- The Board discussed seven correspondence issues.

Special Meetings

The Board held several special meetings in September. Minutes for these meetings are posted on the bulletin board outside the Clubhouse. The topics of the meetings were as follows:

- September 5—Board discussed appointing two new directors to take seats left vacant by resignations of Reba Glover and Nat Hutton. The Board voted to appoint candidates from the Annual Meeting election who had highest number of votes, Joe Khoury and Dan Frank. Khoury and Frank accepted the nominations.
- September 16—Board discussed the 2010 budget
- September 23—Meeting with Gafcon to discuss the condition assessment report for the property

Ongoing items

- Lighting Enhancement Survey—Board approved additional lighting per the suggestion of the Safety Committee.
- GAFCON—A special meeting was held on Wednesday, September 23rd for Gafcon to explain their Property Condition Assessment report and associated costs.
- Chimney caps/spark arrestors—The Board approved 6 additional chimney caps. This will complete the one-story bungalow units.
- Bathroom Tiles—Dan Malloy has made enough tiles for us to begin our re-piping work for 2009. Enough tiles to complete the entire re-piping project will be delivered by end of September. Additionally, homeowners will be receiving a flyer allowing them to purchase replacement tiles that match the original 1940s wall tile. Court Council to distribute flyer. Homeowners are asked to return flyer to Manager no later than October 15th.
- Sewer Replacement Project—Work in Courts 8 and 9 will begin on Monday, October 5th. Notices have been sent to effected homeowners. Work should take five weeks and be complete before Thanksgiving.
- Structural Engineering Services—The meeting date for Risha Engineering is set for Thursday, Oct 1, 2009 at 6:30 p.m. Discussions will include clarification on costs presented in letter received from Risha and also considering Risha for the project manager for this work to Buildings 8 and 14.
- Concrete Repairs—Work has been laid out and will be completed in three phases. Phase 1—Courts 1, 2, 3, 15, 16, and 17. Phase 2—Courts 4, 5, 6, 14, WC, and EC. Phase 3—Courts 7 through 13. Work began on September 14th and should be complete by October 16th
- Garage Court Signage—signs on order and expected to be here on October 2nd.

Completed items

- Chimney Caps—all caps have been installed.
- 2009 Exterior Building Painting—Building 85 is complete. All 2009 buildings are complete.

Platt Security Report August 16–September 15, 2009

- August 16—Court 7, 12:00, a barking dog complaint, security officer arrived but no barking was heard.
