#### **Board Highlights**

At its meeting on August 26,
the Board of Directors:

- \* Approved a resolution to complete the sewer lines replacement project by the end of 2015, one year sooner than previously planned.

  East/West Circles and Courts 1, 14, 15, and 17 will receive new sewers. The total cost of \$1,038,300 will be paid through Special Assessment funds.
- Directed the manager within 30 days to put out a request for proposals for escort and patrol services. Platt Security will be included.
- \* Authorized a Pancake Breakfast and Disaster Preparedness Fair on Saturday, Oct. 11 at the Clubhouse.
- \* Accepted a request from the Los Angeles Conservancy to participate in their Garden Apartments Tour in early November.

## Manager's Report

\* Building Stabilization
Final Report: Village
Green's Building
Stabilization Project, which
stabilized and repaired
Buildings 8 (Court 2) and 14
(Court 3), is now complete,
with only the re-landscaping
still to be done. The
project's total cost is
\$1,147, 994.50, paid through
homeowners' Special
Assessments.

The project got under way in 2013 after years of studies amid resident complaints of building shifting. Helical piles were chosen as the stabilizer, a project services company was hired, and the Village Green office became the project manager.

- \* **Painting:** Residential Building 33 (eight units) is scheduled for painting on Sept. 15, and Court 13 garages on Sept. 4.
- **Trash Bins:** Village Green's trash disposal company, NASA, reports that trash bins refurbishment has been completed.
- \* Patio Trees: If you have or are thinking of buying a patio tree, please see the Village Green Handbook, Section 8.3, "Trees and Plants in Patios," for conditions and limitations. Also please note that care of patio trees, including pruning, is the owner's responsibility. If the manager determines that pruning or removal is needed to maintain the integrity of common area or a building, the Association will prune or remove it.

\* July 16 FIRE IN TRASH BIN. Court 11, 9:45 a.m. A resident reported a fire in the court trash bin and extinguished it. The responding Platt officer observed charcoal on top of plastic in the bin.

- \* July 24 COMPLAINT. Court 10, 3:15 p.m. A resident reported being physically threatened by another resident in the laundry room. He filed a report with LAPD.
- \* July 24 VANDALISM. Court 11, June 24. 7:15 a.m. A resident reported the back window of his vehicle smashed. No items were taken.

Following company policy regarding parked cars, the responding Platt officer called her dispatch. Access was restored when the vehicle's owner was located and moved the vehicle.

- \* Late July MISSING CHILD. Court 1, 2:25 p.m. A grandfather supervising his young granddaughter while she rode her bike lost sight of her and could not find her. Residents and Platt Security helped the grandfather in his search and the little girl was eventually found and escorted home.
- \* August 5 PROPERTY DAMAGE. Court 8, 3:45 p.m. A Platt officer responded to a report of a car backing into a garage resulting in minor paint damage and a broken side light on the vehicle. The driver, a non-resident, refused to provide any identifying information.
- \* August 5 DISCOVERY OF A DECEASED RESIDENT. Court 4, 8:00 a.m. An LAPD officer advised Platt Security that LAPD and the coroner's office was on the property after a resident was found dead on the grounds in the area of Court 4.
- \* August 7 FALLEN TREE BRANCH AND DAMAGE COMPLAINT. Court 15, 10:45 p.m. A Platt officer observed a fallen tree branch near a parked car. And on Aug. 9 at 3:42 p.m. in Court 15, a resident reported scratches on her car caused by the branch.
- \* Aug 11 THEFT. Court 17, 10:30 a.m. A resident reported that someone he knew had stolen tax documents from his unit, setting off the burglar alarm.

#### Preparing for a Citywide Emergency

The recent Napa earthquake is a reminder that Village Green residents need to prepare for a similar event here. In the last 52 years, Village Green has weathered several large earthquakes, a flood, and the civil unrest of the LA riots. Yet despite these city-wide emergencies, few of our residents are ready for one.

Do you have the recommended three gallons of water per person? An emergency kit? A second emergency kit in your car? Access to a working fire extinguisher? A plan to reunite with your family if you are separated?

For many Village Green residents, the answer is "no," and the Ad Hoc Disaster Preparedness Committee is trying to do something about it. Focused on helping neighbors help themselves and each other, this group will be encouraging

Village Green residents to prepare themselves for the next disaster. Please join us at the Platt Pancake Breakfast and Disaster Preparedness Fair on Saturday, Oct. 11, 9:30 a.m. – 12:30 p.m. (See page 4 for details.)

Preparing yourself and your family should be the first step. The City of Los Angeles Emergency Management Department (EMD) offers an online brochure guiding residents to create an emergency kit and a plan to address the needs of the household. In addition, the Great California Shakeout, taking place this year on Thursday, Oct. 16, is a wonderful annual event that encourages all California residents to role play as if a major earthquake has struck.

The layout of Village Green actually makes preparing for an emergency much easier than it would be for owners of single family homes. Our courts and greens are natural meeting areas to offer and receive help from your neighbors. According to the EMD, defining a meeting place is a key step for a community to be prepared.

Our various committees connect our residents in ways that many LA neighborhoods cannot. This enables us to identify residents who may need assistance in the event of a disaster. Also, residents with important skills, such as nurses or general contractors, can be identified in advance. So, work with your Court Council reps and the Safety Committee to get to know your neighbors—they will be your best resources.

Keep in mind that there is no opting out once a disaster occurs. Please do your part to be in a position to help yourself, your family, and your neighbors. Prepare for a citywide emergency. For more information, visit the EMD website at emergency.lacity.org.


#### Call 911 in Emergency

A reminder that in an emergency at the Village Green, call 911 before calling Platt Security. Such situations include when you feel threatened or experience or witness any criminal or suspicious activity or medical emergency. Report any suspicious activity you see to Platt Security by calling 800-986-3868. However, be advised that Platt Security is a private security company hired by Village Green and not an enforcement entity; the primary function of its officers is to observe and report. In an emergency, you should rely on 911 emergency services such as the police or fire department.
