NEWS FROM THE VILLAGE GREEN BOARD *By Lucy Fried*

The September BOD meeting began with an important report on tree trimming and tree care from our longtime arborist, Cy Carlberg.

Reflecting the Tree/Landscape Committee's concerns as well as her own, Cy explained the need for direct communication between the arborist and tree care company and discussed current pruning shortcomings. Three companies, including the current one, will be invited to submit pruning bids.

Directors then discussed three topics, with votes scheduled next month:

(1) 2022 Budget Priorities

VG has an operations budget and a reserves budget. Reserves includes money set aside for our major rehab projects such as the electrical and irrigation systems and landscape rehabilitation.

VG treasurer Claire Knowlton and the other directors took a hard look at both budgets in September and concluded that the VGOA would need to make significant increases in assessments to afford these projects over the next ten years. Increases of 4-20% were mentioned. The board must approve both operating and reserves budgets in **October**.

(2) New Fines Guidelines for Unapproved Architectural Modifications

Another discussion item regarded a new fee schedule for violations of VGOA architectural modifications guidelines, i.e., unapproved architectural alterations. The new schedule reflects the severity of the violations and is intended to discourage people from making changes without approvals.

A team consisting of directors Haleh Shoa and Steve Haggerty, VG Operations Manager Sherri Giles and Maintenance Engineer Alfonso Casanova, and DRC Consultant Linda Pollari developed the guidelines. Haleh will bring the proposed **Handbook** revision for a board vote in October.

(3) HOA Consultant

Earlier this year, directors agreed to reach out to consultants for an assessment of our systems, processes, practices, staffing, and policies. In September, they formed a subcommittee to clarify the scope of work. □

BIG OIL NEWS

In September, LA County Supervisors voted unanimously to move toward a complete ban on drilling in unincorporated County areas. That includes the Inglewood Oil Field, which has been uphill and upwind of the Village Green since its construction.

MANAGEMENT NEWS *from Operations Manager Sherri Giles' September Board report*

“NO TREE CLIMBING” SIGNS As of September 25, five signs – two metal and three temporary signs produced by the office – have been removed/stolen from areas near trees that children are often reported to climb. Management requested a board decision on whether to install a new metal sign in a concrete footing.

HIGH VOLTAGE NEWS Management and the board continue seeking the most advantageous pathway and transformer site for the 34.5 kilovolts of power that DWP will provide the Green. Sites on the NE and SE corners of the property have been surveyed, and now we are waiting for the DWP to comment on the suitability of obtaining the power from the lines running along the alley west of C&S nursery on Hauser. This would bring the power lines much closer to the Green than from the proposed LaBrea power source.

THE COURT 9 WATER SUPPLY LINE REPLACEMENT project has begun and will run through most of the month. **Painting/Insulation** is on schedule, work on Building 49 is to begin on the 18th. **Greencrew** will be detailing courts 15-1 this month. □

NEIGHBORS DISCUSS HUMAN TRAFFICKING AND IMPORTANCE OF SEX EDUCATION

In 2019, former VG board president Jerri Allyn and film maker Adisa Septuri discovered they were neighbors with a mutual concern: human trafficking. They were in San Pedro at the annual See It - End It Film and Art Festival, a community event that raises awareness of human trafficking. Adisa's film, *SKIN IN THE GAME*, was screening at the festival, and Jerri was a contributing artist and team member organizing other artists.

These two busy people ran into each other again this summer and agreed to share their takes on human trafficking and the importance of sex education with **Highlights** readers.

Note: This article discusses sensitive subjects.

Adisa: My sister brought sex trafficking to my attention. (A trafficked person is illegally brought from one place to another for forced labor or sexual exploitation.) I was visiting her in Oakland, and she wouldn't let her daughter ride the bus because a young girl had been nabbed by a "guerrilla pimp". Many more girls are coerced or lured into the commercial sex trade. It's no different than slavery. The predators just want to make money.

Jerri: For me, this problem is tied to the scarcity of sex education in schools, neglecting to educate youth about their bodies and pleasures and warn about predators. I was sexually assaulted as a kid. My parents buried my assault under the rug and I never got the factual sex education I needed. Mentors, lovers, and art healed me, returned me to my soul.

Adisa: It broke my heart to hear young women telling stories about being prostituted at 9 years old. So I started research in earnest, directing and filming *Skin in the Game*.

My wife didn't want anything to do with it. Just the thought of this subject matter creates trauma. She was pregnant with our second daughter. She does support me, did finally see the premiere, and thought it was great, though disturbing.

I also learned that pornography can be a gateway to sex trafficking, and the stats reveal a disproportionate percentage of girls of color are coerced. Systemic racism is pervasive, even in recovery resources. White girls generally have access to many more resources.

Jerri: As a teaching artist, I'm frustrated with schools and principals that deliver one unit of Sex Ed about transmitted diseases, but little else. The backlash against wholistic Sex Ed, coupled with the rise of easily available exploitative porn online, has resulted in youth getting "educated" via Porn Hub.

Adisa: ... and porn sites feature too many videos of young men being sexually aggressive with young women - without consent.

Jerri: Systemic sexual violence ... Parents, talk to your kids about sex!


Adisa: The biggest challenge? Denial. "My kid doesn't watch porn and wouldn't think of raping a girl!"

Jerri: I did a poster project with teens who confided that they're learning about sex through hookups on *Tinder* and *Grindr*. I said, "Let's discuss how you can keep safe while dating and keep alert for predators." We came up with 10 strategies, such as, "Always tell someone where you're going".

A GAMECHANGER AMONG US

The achievements of West Circle’s Jason H. Williams were recently commemorated at the University of Maryland’s new Jones-Hill Football Complex, named after two African-American UM athletes who broke the school’s color barrier in football.

Inside the complex is a permanent exhibit called Gamechangers Row, where Jason is honored as the **first Black UM athlete (1962-66) to compete in a collegiate team event at UM (springboard diving) and the first Black athlete to compete in the Atlantic Coast Conference** (Maryland, West Virginia, Pennsylvania, North Carolina, and South Carolina). □
