News from the Board Compiled by Patrick Comiskey

Thirty-two people attended the August 21 Board Meeting including nine board members and the management team.

Baldwin Vista Green Streets Project

Lorena Matos of the L.A. Department of Sanitation presented plans for a rainwater catchment project being developed for the Baldwin Hills. It will involve planting new trees and installing drainage catchment areas called bioswales along the south side of Coliseum between Nicolet and Hauser. If the project is funded, work will begin in 2024.

Art Show Benefit for Cultural Affairs

The Cultural Affairs Committee proposed using the Clubhouse for a show and sale of the artwork of the late

resident artist, Harold Pelster. The Board unanimously approved the use of the Clubhouse for the event and voted 8 to 1 to use all proceeds for the purchase of a new event stage.

White Boards

The Board approved the purchase of two large-scale, custom whiteboards, featuring a graphic map of the buildings and grounds, to assist with project management and maintenance assignments, at a cost of approximately \$1500.

Marie Germaine was approved as chair of the Communications Committee; Patrick Comiskey was approved as editor of *Highlights*. □

Electrical Upgrade Project: The electrical pilot project in Building 91 proceeds. Work in six of the building's eight units has wrapped up and rewiring for last two units will be finished in September.

Residential Building Painting/ Insulation: Building 2 was completed on August 11. On August 14, power washing began at Building 17 in Court 4. Carpentry repairs and insulation began August 16 and is scheduled to be completed by end of August.

Garage Restoration and Painting:

Courts 3, 7, and 11 have been selected for Garage Restoration, tentatively scheduled to start in Fall 2023. The garage restoration project will include termite treatment of the garage buildings, carpentry repairs and new paint; this year the process will also include roof and garage foundation repairs.

Metal Window Frame Repair/ Replacement: Four homeowners have volunteered their windows to test the feasibility of rehabilitating existing windows. Facilities Engineer Linda Pollari is working with a vendor to obtain pricing and present a proposal at the September 26 Board meeting.

Serpentine Walls: Contractor Troxler and Sons is still seeking to resolve issues involving the brick used for serpentine wall repairs. LAOHR recommended Troxler obtain samples of Carolina Brick Company's hand-cut brick product. However, Carolina mandates a minimum order of 34,000 bricks, far more than the approximately 4,000 needed for upcoming wall repairs. Carolina recommended Troxler contact a smaller local distributor that might have a lower minimum.

Security Services: As reported last month, the Association's security contract has been put out to bid. Safety Committee Liaison Steve Haggerty and Board President Laura Civiello hosted a virtual town hall on Thursday, August 3 for residents wishing to offer feedback and suggestions to inform the RFP process. In addition to Public Security, Management solicited and received RFPs from six security companies. The Board will review submitted proposals with the goal of making a final selection at next month's board meeting.
